ARCOLA MUNICIPAL MANAGEMENT DISTRICT NO. 1

The Board of Directors (“Board”) of Arcola Municipal Management District No. 1 (“District”) will hold a regular meeting, open to the public, on **Wednesday, October 11, 2023, at 6:00 p.m., at The Muller Law Group, PLLC, 202 Century Square Boulevard, Sugar Land, Texas 77478** to discuss and, if appropriate, act upon the items below.

 - d. approval of pay estimates and change orders and acceptance of projects, as appropriate, for construction of projects in the service area, including:
 - i. hardscape & landscape to serve Post Oak Pointe, Phase 1;
 - ii. City of Arcola lift station no. 1 – replacement;
 - iii. Post Oak Pointe, Recreation Center;
 - iv. City of Arcola wastewater treatment plant upgrade;
 - v. water, sewer, drainage, and paving to serve Post Oak Pointe, Section 5; and
 - vi. City of Arcola Lift Station No. 2 Force Main.
 - e. permits, deeds, easements, consents to encroachment, and utility commitment letters;
 - f. update on bond application; and
 - g. Utility Conveyance and Security Agreement.

8. Update and action on matters related to Reinvestment Zone Number 1, City of Arcola, Texas.
9. Next meeting date.
