ARCOLA MUNICIPAL MANAGEMENT DISTRICT NO. 1

The Board of Directors (“Board”) of Arcola Municipal Management District No. 1 (“District”) will hold a regular meeting, open to the public, on **Wednesday, November 8, 2023, at 6:00 p.m., at The Muller Law Group, PLLC, 202 Century Square Boulevard, Sugar Land, Texas 77478** to discuss and, if appropriate, act upon the items below.

 - i. hardscape & landscape to serve Post Oak Pointe, Phase 1;
 - ii. City of Arcola lift station no. 1 – replacement;
 - iii. Post Oak Pointe, Recreation Center;
 - iv. City of Arcola wastewater treatment plant upgrade;
 - v. water, sewer, drainage, and paving to serve Post Oak Pointe, Section 5; and
 - vi. City of Arcola Lift Station No. 2 Force Main.
 - e. permits, deeds, easements, consents to encroachment, and utility commitment letters;
 - f. update on bond application; and
 - g. Utility Conveyance and Security Agreement.
8. Approval of engagement letter with Beck Redden LLP for litigation services.
9. Report on development.
10. Update and action on matters related to Reinvestment Zone Number 1, City of Arcola, Texas.
11. Next meeting date.
